Community Center/Pool Report New Parks and Recreation Director

Taylor Beacon was introduced to Council. Activities at the Community Center are slowly getting back to pre-pandemic levels. New summer hours have begun. The center will be open Monday through Friday, 5:30 a.m.-7 p.m.; Saturday, 8 a.m.-2 p.m.; and closed on Sunday. Summer youth sports are very busy and will continue into July. The pool opened on May 29th and, as of the report, averaged 47 patrons daily. 23 Family passes have been sold and 18 single passes (adult and child) with one punch pass being purchased. Red Cross swim lessons are planned for July.

Library Report

Director Emily provided her report to the council. The women's restroom is still undergoing renovation. The Summer reading program theme is "Reading Colors Your World". Several activities are planned for the summer.

Taxi Report

For May, the taxi had 141 rides, 386 stops and 22 days of driving.

Administrator Report

There were four building permits issued in May. Thirty letters and warnings were issued for mowing and trimming. 5 letters have been sent for junk vehicles and general yard clean-up. Pudenz informed council the Public Safety Commis-

sion agreed on the percentages each city and Ida County would pay towards Unified Law. Pudenz gave an update on the new Aquatic Center construction.
