County Engineer Jeff Williams presented 3, 2023 pickup truck bids as follows: 2 - 3/4 ton Chevrolet Siverado 2500HD Double Cabs at \$56,236.10 and a 1 ton Chevrolet Silverado 3500HD Double Cab at \$53,254.30 from Vollmar Motors and a 2 ton Ford 2022 F550 4X4 pickup from Beckman Motors for \$59,350.00. Schubert moved and Leonard seconded a motion to approve said bids. Motion carried, all voting Aye.

Leonard moved and Schubert seconded a motion to approve and authorize the Chair to sign an application for under-ground construction for West Central Iowa Rural Water Assn. located in Blaine Township-Sections 35 and 36 at 2768 Quail Ave. Motion carried, all voting Aye.

A motion by Leonard and seconded by Schubert to approve Dalton Sheer Treiber, County Assessor Administrative Assistant, at \$20 per hour effective Dec. 5, 2022 and \$21 per hour after a successful 60 day probationary period. Motion carried, all voting Aye.

Schubert moved and Leonard seconded a motion to approve and authorize the Chair to sign a letter for a Bomgaars Grant for the Ida County Trust Fund to the Ida County Fair Board. Motion carried, all voting Aye.

A motion by Schubert and seconded by Leonard to approve Resolution 22-41 transferring \$146.62 from the Assessor's Fund to the Public Safety Fund for an accounting error. Motion carried, all voting Aye.

Schubert moved to approve and authorize the Chair to sign a bid from Claeys Brothers Moving Company, for courthouse relocating of offices, in the amount of \$5,915 to move out and \$5,785 to move in. Leonard seconded the motion and it carried, all voting Aye.

Discussion was held on closing the courthouse to move offices to other locations in the courthouse on Jan. 19 and 20 and possibly the morning of Jan. 23 for the courthouse renovation project.

The Board acknowledged receipt of manure management plans from Norton Finisher Farm/ Working Farms, LLC; Arthur Finishing/AMVCRE, LLC; GN2/ Gary Nachazel.

The following claims were approved from the Self-Funding Fund-Benefits, Inc-\$108.76, 103.60 and 108.60.
