Landfill updates that are required

by the DNR by Aug. 1, 2024, were discussed. Whiteing and Engineer Williams will schedule the work for completion.

Nathan Kistner, Corinne Erickson, and Dawn Kimmel, with Simpco are continuing to research possible grants and/or matching funds to help pay for the Courthouse Building remodeling project.

The Clerk of Court Monthly report for April 2024 was reviewed. Schubert moved and Drey seconded the motion to accept the report. Motion carried, all voting Aye.

Payment on Resolution 24-13 General Obligation bond 2021 for service fee of \$600.00 was moved by Schubert with Drey seconding the motion. Motion carried, all voting Aye.

On or after June 21, 2024, the City of Holstein will submit a request to the State of Iowa, Iowa Economic Development Authority for the release of Community Development Block Grant funds under TITLE 1 of the HOUSING AND COMMUNI-TY DEVELOPMENT ACT OF 1974. as amended (P.L. 97-35) to undertake the following project:

Project Title: CDBG Wastewater

Plant Improvements Project Purpose: The need for the City

to comply with mandated improvements to the treatment process based on the new requirements of the IDNR permit for the treatment facility.

Location: The project activities will take place at the City of Holstein Wastewater Treatment Facility Iocated at 5600 German Avenue on the south side of the City. The activities will take place on land owned by the City of Holstein.

Estimated Cost: CDBG Funding = \$500,000 Total Project Cost = \$5,455,000

FINDING OF NO SIGNIFICANT IMPACT

EXPLANATION OF A PROPOSED ACTIVITY IN A FLOODPLAIN

OR WETLAND This is to give notice that the City of Holstein has conducted an evaluation as required by Executive Order 11988 and/or 11990, in accordance with HUD regulations at 24 CFR 55.20 Subpart C Procedures for Making Determinations on Floodplain Management, to determine the potential affect that its activity in the floodplain and wetland will have on the human environment for a CDBG Wastewater Plant Improve-

ments Project (#24-WS-007). The project involves the construction of a new wastewater treatment process which includes a new SAGR treatment system and ultraviolet disinfection system. Specific components of the project include process piping, aeration piping, a splitter structure, blower building, electrical system, controls, and various other minor components. Portions of the project are located in a

floodplain and wetland. The City of Holstein has considered the following alternatives and mitigation measures to be taken to minimize adverse impacts and to restore and preserve natural and beneficial values:

Four alternative wastewater treatment improvements were considered for this project, including LEMNA Covered Aerated Lagoon and Polishing Reactor (Partial Mix), OPTAERTM Aerated Lagoon and Submerged Attached Growth Reactor, Algae Wheel Rotating Algal Contactor (RACTM), and LEMNA Polishing Reactor Cell.

Reasons for Selection of Proposed Alternative: Alternative 2, Aerated Lagoon and Submerged Attached Growth Reactor, was selected because, while this alternative's capital cost is high, maintenance for this type of treatment system is most advantageous to the Operator. This system will meet the required effluent limits, is relatively simple to operate, and should serve

the City well for many years. Do-nothing alternative is not an option as it would prohibit City from complying with mandated improvements to the treatment process based on the new requirements of the IDNR permit for the treatment facility.

The project site was selected for the availability of land (it is already City-owned) as well as minimization of the impacts to the environment. There are no practicable alternatives to locating the project in a

floodplain and wetland The City of Holstein has reevaluated alternatives to the project and has determined that it has no practicable alternative. Environmental files that document compliance with steps 3 through 6 of Executive Order 11988 and/or 11990, are available for public review at the address delineated in the last paragraph of this notice for receipt of comments. This activity will have no significant impact on the environment as only a small portion of the project is lo-

cated within the floodplain and a

wetland.

There are three primary purposes for this notice. First, people who may be affected by activities in floodplains or wetlands and those who have an interest in the protection of the natural environment should be given an opportunity to express their concerns and provide information about these areas. Second, an adequate public notice program can be an important public educational tool. The dissemination of information about floodplains and wetlands can facilitate and enhance Federal efforts to reduce the risks associated with the occupancy and modification of these special areas. Third, as a matter of fairness, when the Federal government determines it will participate in actions taking place in floodplains or wetlands, it must inform those who may be put
