Notice is hereby given that the Board of Directors of the Galva-Holstein Community School District, in the Counties of Buena Vista, Cherokee, Ida, and Sac, State of Iowa, will hold a hearing upon its Resolution to Consider Continued Participation in the Instructional Support Program. The hearing will be held in the Holstein Media Center, 519 E. Maple Street, Holstein, Iowa 51025, on Jan. 8, 2024, at 6:30 p.m.

The Board of Directors is considering continued participation in the Instructional Support Program as provided in Sections 257.18 through 257.21, Code of Iowa, for a period of five years, commencing with the fiscal year ending June 30, 2025.

Additional funding for the Instructional Support Program for a budget year will be determined annually by the Board of Directors and will not exceed ten percent (10%) of the

total regular program district cost for the budget year and moneys received under Section 257.14, Code of Iowa, as a budget adjustment for the budget year.

Moneys received by the District for the Instructional Support Program may be used for any general fund purpose.

The Instructional Support Program shall be funded by instructional support state aid and a combination instructional support property tax levied annually upon the taxable property within the School District commencing with the levy of property taxes for collection in the fiscal year ending June 30, 2025, and an instructional support income surtax imposed annually, the percent of income surtax to be determined by the Board for each budget year to be imposed upon the state individual income tax of each individual income taxpayer resident in the School District on Dec. 31, 2024, and each year thereafter.

Dec. 20, 2023**

The Galva-Holstein Board of Education met in work session on Wednesday, Dec. 20, 2023 at 6 a.m. with the following members present: Grant Aschinger, Don Kalin, Tara Ruble, Jamie Whitmer, Matthew Wittrock, and Jeff Witzke. Absent: Beth Schossow.

Administration Present: Superintendent Bisenius.

Visitors: Corvin Griffin, Braden Meints, and Cory Tiefenthaler (6:20 a.m.).

Meeting called to order by President Whitmer at 6 a.m.

Motion by Kalin, second by Witzke to approve agenda as presented. Motion carried unanimously. Bisenius presented a financial projection model to the board based on assumptions of decreased revenue sources with ESSER funding ceasing and increasing expenditures. The goal is to get ahead of the projected deficit spending with a planned strategy.

Next the board discussed various facility goals including additional classrooms, remodeled or new weight room and wrestling room, district fencing, and other smaller projects.

Finally, opportunities for student programs were discussed. President Whitmer adjourned the meeting at 7:20 a.m.
